- Customer must supply sample panel at time of promising for custom wood finish

Definition of "Estimated Lead time":

- Order available for shipment within this lead time. Contingent on finish approvals for custom matches and customer's own material availability
- Lead time listed is an estimate. Actual leadtimes may vary due to order size and inventory levels.
